1. ACCIDENT/INCIDENT REPORTS:

3. NEW BUSINESS

UBC Risk Management – Inspection of all EOAS Laboratory Spaces – TN informed the committee that Risk
Management will inspect labs in all UBC buildings. Post-inspection, individual PIs will receive corrective action
forms and be asked to rectify deficiencies. Individual PI's will work within their groups to correct any issues. The
EOAS/ESB Safety Committee is not meant to follow up with the PI's after the Risk Management inspections.
Statistics from the inspection will be sent to the Deans, Department Heads, and local Safety Committees. The
EOAS/ESB Safety Committee will undertake own inspections in the fall of 2017.

- Phone in EOAS Basement Rock Storage and Prep Room RH reported that the phone has been installed.
- Kitchen Fire Hazards RH explained that UBC does not have a policy that prohibits the use of electrical kitchen items. TM will continue to monitor each EOAS building for any defective or inappropriate items.
